Dear Parent or Guardian:

This is the third school year that the Juniata County School District has implemented the iPad into the Limitless Learning Program. We are excited to have this opportunity to put technology into the hands of your student. By having this technology and the applications (apps), we now have the capability to increase the creative learning opportunities for everyone, both teachers and students.

Textbooks, pens, pencils and paper are not going away anytime soon, but you will see our students developing more projects and assignments on the iPad. The Juniata County School District has been trained and will continually train our teachers on how to bring fresh new lessons that motivate our students to achieve. The teachers and administrators have chosen the iPad applications that encourage our kids to create musical, video and other artistic projects that appeal to all learning styles. All the apps that students will need will already be on the device. Students will receive instructions from their teacher when new apps are needed for their classes. Students will also learn how to safely use the technology and will become familiar with our responsible use and internet safety protocol.

At the beginning of the school year, your child will receive an iPad along with an iPad case. If you choose for your child to take the iPad home, please fill out the attached forms, return the forms along with the insurance payment. You may also make the payment on My School Bucks on the District Website (fee has been waived for this usage). Payments may also be sent to the District Office in care of Mrs. Polly Digon, secretary to the Superintendent at 146 Weatherby Way, Mifflintown, PA. Checks can be made to JCSD. Please include the student's name and school in the memo line. There is some responsibility that comes with this opportunity. Just as our students have cared for the textbooks issued to them, your student will need to care for the iPad. If your child damages the iPad or iPad case, in or out of school, you will be responsible for the full replacement cost regardless of the circumstances. The cost to replace an iPad and charger will be \$300.00. The cost to replace a damaged case will be \$100.00 for grades 9-12 and \$35.00 for grades K-8. We highly recommend that all families purchase the insurance policy, though it is mandatory if the child is going to take the iPad home with him/her. The annual protection fee will cover the replacement cost of the iPad and cover for one calendar year.

For your protection and convenience we are offering an Annual Protection Fee as determined by the student's lunch status:

\$35.00 full pay

\$25.00 Reduced \$15.00 Free

Insurance does not cover charger or cord replacement. Insurance payments are due by October 1, 2018. Any payment received after October 1, 2018 can be purchased for \$50.00 regardless of economic status. Students enrolling after October 1, 2018 will have 30 days to purchase insurance at the reduced rate above.

Protection plan covers (1) electronic device repair replacement per school year in the event of theft, loss or accidental damage. Any additional replacement or repair costs will be covered by the student/parent/guardian at the full market value of the device. Families will be billed for costs of replacement/repair. Students will not participate in any activities until full payment is received.

Protection Plan Terms	
A non-refundable protection plan is mandatory for students to take iPads home. However, with the change in policy, the district highly recommends that all families purchase the protection plan. This annual fee is determined by the student's lunch status. The plan is \$35 for regular, \$25 for reduced lunch students and \$15 for free lunch students. The plan includes one electronic device repair/ replacement per school year in the event of theft, loss or damage. Any additional replacement or repair costs will be covered by the student/parent/guardian at the full market value of the device. Cords and charging bricks are not covered in the plan. Insurance payments are due by October 1, 2018. Any payment received after October 1, 2018 can be purchased for \$50.00 regardless of economic status. Students enrolling after October 1, 2018 will have 30 days to purchase insurance at the reduced rate above.	
Damages covered	
Students/parents/guardians who purchase insurance will be covered for the entire cost of replacement or repair of devices damaged through active misuse, abuse or unintentional damage.
